Overall purpose of the job

Our Community Led Nature Restoration Project will provide the catalyst for a County-wide scale, community led nature recovery approach. The project aligns with the Council's ambition to support our communities and natural environment to adapt and thrive as the climate changes.

To support the achievement of our ambitions, the Community Nature Project Officer will oversee the project to create and implement Community Nature Recovery plans and enable a step change in the delivery of nature recovery within the most deprived and nature depleted open spaces in Cambridgeshire.

The role will use knowledge and understanding of project management and reporting to successfully deliver and monitor the Community Led Nature Restoration project and associated workstreams.

Main accountabilities Coordinate project management of the County Council's Community Led Nature Restoration Project, 1. using skills and experience of environmental policies and legislation to direct, guide and manage project delivery to ensure objectives are delivered to a high quality, forecast delivery times and budget targets. 2. Monitor and report project progress regularly to the programme manager, project sponsor and project board. Proactively and positively provide challenge and suggestions to improving the project's delivery, in particular in relation, to ensuring that the benefits and outcomes are delivered. 3. Implement risk monitoring and management processes in accordance with corporate guidelines. Ensure programmes reflect all highlighted risks. Liaise with the Project Sponsor, Project Board and key stakeholders to establish the scope and 4. definition of the projects, secure agreement to timescales and the provision of the necessary resources and confirm the required outcomes and success criteria by which the project will be evaluated. Ensure that the project objectives align with the strategic objectives of the organisation 5. Procure and manage consultants/ specialist teams in line with the Council's processes to support the development of Community Led Nature Recovery Projects. 6. Lead on key aspects of project expertise within nature restoration to ensure the highest level of knowledge and experience are used in resolving issues and enquiries. 7. Promote, develop and maintain effective partnerships and collaborative working with a range of stakeholders including other authorities, public bodies, voluntary and private sector organisations to ensure the appropriate level of coordination that will achieve the objectives of the project. 8. Ensure the project meets the needs of users and the local community, working with the Community Nature Engagement Officer to seek input from communities, businesses, councillors, stakeholders and potential users. 9. Demonstrate an awareness and understanding of equality, diversity and inclusion. 10. Ability to contribute to our organisational commitment to becoming a Net Zero organisation by 2030.
