Purpose Of Post	Within the specialism, to deliver adult learning opportunities and to assist and support its development and delivery by the Adult Learning Service and its partners.

PRINCIPAL RESPONSIBILITIES

1. Provide a scheme of work and other related information, including course and lesson planning and preparation of appropriate teaching resources.
2. To undertake scheduled teaching activities, student assessment and tutorials.
3. Provide support to learners including pre-course, on course and exit advice and guidance as directed by the programme management team.
4. Participate in training and other continuous professional development including induction, staff meetings, tutor forums and on-line training packages (including those related to Inspection).
5. Participate in developing and implementing quality assurance arrangements and administrative duties relating to the course.
6. To promote equality of opportunity and diversity in line with Northamptonshire County Council Policy.
7. To take responsibility for Health and Safety issues relating to the course and the students in compliance with Northamptonshire County Council Health and Safety Policy.
8. To contribute to marketing and publicity initiatives relating to adult learning programmes.
