Job Title: Active Travel Officer

Overall purpose of the job

Cambridgeshire County Council has ambitious plans for the future development of its transport network in order to tackle the climate emergency, clean up our air, support active and healthy lifestyles and facilitate improved economic opportunities and growth. Increasing the number of people making their journeys by foot or by bike will form a key part of our work over coming years.

To achieve our ambitious vision for increasing walking and cycling uptake, coordination across all aspects of the council's operations will be necessary. The postholder will undertake work supporting the Active Travel Manager and the Principal Active Travel Officers in delivering the work of the team. Working agilely across council departments and in partnership with key external organisations including Active Travel England, the Cambridgeshire and Peterborough Combined Authority and Greater Cambridgeshire Partnership. This post focuses on identifying opportunities for improving facilities for, and uptake of, active travel modes of transport.

Depending on where the demand is at a particular time, postholders may support work on developing Active Travel schemes, auditing Active Travel provision in transport schemes, working to develop Active Travel policy, or working on the promotion of Active Travel. The Active Travel team will also function as key local centre of excellence on active travel, proactively leading on the sharing of knowledge and best practice with all relevant stakeholders.

Ensure regular and timely exchange of relevant project information with internal and external stakeholders in order to maintain a mutual awareness of programme delivery and timings.</p>
