#### **Overall Purpose of Role**

Delivering timely and relevant interventions to young people who have or are at risk of causing harmful sexual behaviours either directly or indirectly to others. This service provides support to young people who are at risk of causing sexual harm to others and their support network. This includes social workers, foster carers/parents, education providers, social activity providers. The service provides assessments and interventions, to the young person and their non-abusing family.

This service is essential to reduce the risk of further harmful sexual behaviours occurring, assist in maintaining placement stability; either in the family home or foster care, to provide advice and guidance in relation to safeguarding to education providers.

This service provides information relevant when seeking further services, especially when there has been an increase in risk.

#### **Main Accountabilities**

	Main Accountabilities
1	To provide high quality interventions; relevant to the young person and their circumstances, who have caused or at risk of harmful sexual behaviour.
2	To undertake specialised assessments; AIM3, providing a clinical analysis in relation to the harmful sexual behaviour.
3	To produce written records of the intervention sessions on the young person's electronic record, within Northampton's Children Trust and analysis and progress of the intervention being undertaken.
4	Work with families and carers to promote effective risk management and supervision to support stability at home and achieve a positive change.
5	To produce written reports evaluating young person's progress and assist in the case management process via promoting effective inter-agency working – risk management decisions.
6	Provide consultancy, advice and guidance to social workers in relation to their clients presenting with sexual harmful behaviours.

	To promote the service and awareness of the specialised work being conducted by undertaking presentations and talks about the Service to teams within the Trust and outside organisations and agencies.

	To support the professional development of others; providing information, resources and guidance to social workers whose clients have demonstrated harmful sexual behaviour.

	To safeguarding and promote the welfare of children and young people/vulnerable adults.
10	To demonstrate awareness/understanding of equal opportunities and other people's behavioural, physical, social and welfare needs.
11	To ensure that reasonable care is taken at all times for the health, safety and
