Purpose and impact:

To be part of a high demanding frontline Housing options Service that is responsible for providing timely housing advice to customers on a range of housing enquiries relating to preventing and relieving homelessness across West Northamptonshire

The postholder will be responsible for managing a varied caseload and provide holistic case management support to address customer need from the initial point of contact through to case closure. They will be responsible for working collaboratively with customers, statutory agencies, the voluntary sector and housing services to provide effective support, decisions and advice on all matters relating to housing options.

Accountable to:

This role is accountable to the Housing Options Team Leaders. The role is within the Housing Options Service, part of the Communities & Opportunities Directorate in West Northamptonshire Council.

Responsibilities:

1. To provide support from the initial point of contact to case closure. To triage, advise, support and assist customers of varying backgrounds in relation to housing and homelessness advice. This will include ensuring support and personalised housing plans are effectively implemented to support customers address route issues and underlying causes i.e. financial, health and wellbeing, and wider determinants.
2. You will be responsible for processing and investigating homeless applications, having a clear focus on working in collaboration with customers to positively prevent and relieve their homelessness. You will have a clear focus on supporting customers to take ownership of their situation and advise them on finding a suitable pathway to ensure they have suitable accommodation whether this be with a family or friend, privately rented accommodation, Council or housing association.
3. To make inquiries as necessary to determine what duty is owed to customers under the Housing Act 1996; as amended Homeless Reduction Act 2017. Ensure that advice and information on housing solutions is readily available and work in partnership with support and safeguarding services as required e.g. social care, health, police, advocacy services etc.
4. To assist in addressing core housing strands in relation to rough sleeping, family exclusion, end of tenancy, domestic abuse, single/couples without children, care leavers, hospitals and prisons to improve the quality of life for customers across West Northants.
5. Have a detailed understanding of, and be able to implement, a wider range of legislation, procedures and policies relating to housing and welfare rights, including homelessness, landlord and tenant law, immigration and asylum, and matrimonial and family law.
6. Ensure all correspondence is responded to appropriately including telephone enquiries, emails and requests from customers, internal departments and external agencies.
7. To undertake interviews and home visits, often on the day of exclusion; within expected guidelines and procedures, ensuring all necessary paperwork and records are effectively maintained in a timely manner.

8. To safeguard customers by providing direct support and ensuring services are aligned to improve their situation. This will include attending multi agency meetings, review of personalised housing plans, completion of safeguarding referrals to social care, police, GP or other, and completion of risk assessments e.g DASH.
9. Work with the Temporary Accommodation & Private Sector Access services to negotiate and secure suitable emergency temporary accommodation for homeless households according to statutory requirements. Work proactively with homeless households to secure suitable housing solutions to help them to move on from temporary accommodation in a timely manner, working to reduce the number of households in temporary accommodation.
10. Contribute to the development of local policies and procedures and promote and facilitate customer engagement and lived experience input to improve service delivery.
11. To be available during office hours in person as and when required to meet the demands of the service. This includes at the One Angel Building and/or from different hubs. To also be available out of hours in line with the needs and demands of the service (both on a rota basis and in the event of an emergency).
12. To maximise personal productivity, minimise duplication and errors; and manage our information efficiently and securely to reduce risk, through effective use of Office 365 and our internal IT systems and applications.
13. Actively challenge and seek to eliminate any directly or indirectly discriminatory practice or behaviours, and be an advocate for equality, diversity and inclusion of customers and Council workforce.
14. Demonstrate awareness and understanding of other people's behavioural, physical, social and welfare needs and ensure that reasonable care is taken at all times for the health, safety and welfare of yourself and other persons.

This job description reflects the major tasks to be carried out by the post holder and identifies a level of responsibility at which they will be required to work. In the interests of effective working, the major tasks may be reviewed from time to time to reflect changing needs and circumstances. Such reviews and any consequential changes will be carried out in consultation with the post holder.
