1.	Contribute to the formulation of strategic Health Protection plan and "core offer" work programme. This includes the identification of health needs and priorities and specialist support
	to deliver "core offers" to the ICB.
2.	Review national policies and guidance and provide highly specialist advice on Health Protection and Healthcare Public Health strategies and practices to the organisations across all sectors. Develop and implement local policies and procedures on Health Protection and Healthcare Public Health aligning with the national policies to meet the local needs.
3.	Ensure the Health Protection and Healthcare Public Health agenda is at the forefront of key strategies and programmes that impact on the long-term health and well-being of the population.
4.	Lead, develop and sustain strategic partnership work that spans organisational and professional boundaries including local authorities, NHS organisations, voluntary organisations and independent sector, to deliver the strategic and operational objectives of the Health Protection functions of Public Health.
5.	Provide specialist Public Health resource to the ICB to deliver jointly agreed "core offers" and to support service reviews and evaluations, needs and impact assessments and economic reviews to inform the commissioning and/or decommissioning of services across organisation boundaries.
6.	Support relevant research activities including review of complex research proposals and working with academic centres and others on collaborative projects.
7.	Responsible for authoring/co-authoring complex Public Health reports and presenting it to various stakeholders and audiences in different formats to disseminate relevant findings.
8.	Continually review current Health Protection and Healthcare practices, making recommendations internally and to other stakeholders to implement improvements in the process and the system.
9.	Responsible for overseeing the community IPC (infection, prevention and control) team of Public Health and supporting maintenance of IPC compliance of social care settings, educational establishments, local businesses and other community organisations within the local authority area.
