In Cambridgeshire Children's Services we have adopted a comprehensive practice methodologies approach to achieving good outcomes for children and families. Central to our approach is a strength-based, trauma-informed relationship model, guided by culturally appropriate practice principles and driven by needs led strategies.

Connecting our practice methodologies will help us to strengthen our practice.

A consistent approach for all children and families

Our practitioners are supported to draw on the use of self in a focused and purposeful way to address and repair developmental trauma in children. Working collaborative with individuals using a goal-orientated communication style with a focus on change.

Everyone who works in Children, Education and Families will use a shared the same set of practice methodologies to deliver a clear and consistent practice approach when working with children, young people, their families and carers, underpinned by a common language.

Our practice methodology will be embedded through all learning activities, supervision and management oversight to support everyone to be confident and skilled in delivering a consistent practice approach.

Connecting our practice methodologies will further support and build a quality learning culture, ensuring the systems are in place to evaluating fidelity and impact.









Spotlight Big Six

In the meantime, we have 6 key areas that we will ensure are a focus of our work with families and the records we keep. These should always form a part of the consideration of effective practice in supervision and without them, practice cannot be considered effective or 'good'.

Every case record will contain at minimum the following up to date areas of practice:

- Genograms and Ecomaps
- Chronology
- Voice of the Child (incorporated into assessments plans and visits)
- Meaningful and planned visits
- Supervision/Management Oversight key decision
- Plans or review of plans and Planning

These are what we call the **Big 6**. They form the basis of all of our practice standards, and they are integral to the records we keep.









Our Practice Standards

Standard

Children will be spoken to alone wherever possible and/or with a trusted adult if necessary to ascertain their voice and lived experience. Observations of very young children should be considered as their voice.

We will work collaboratively with our partner agencies Standard to support children and families to achieve better 5 outcomes.

Standard 2

Children's records will be written in clear, simple, accurate and analytical language about them to enable everyone to understand significant events in their lives.

Children's planning will be effective through the support of supervisors and managers who will provide timely Standard management oversight and supervision. This will include reflective supervision which should consider the Social GRACES.

Standard

Children and families will have an assessment of need that will reflect their wishes and feelings, lived experiences and parenting capacity of parents and carers.

We will use trauma informed approaches, relational and strength-based approaches to improve the lives of children and families.

Standard 4

Children and families will be involved in individual family focused plans that will explain what needs to happen, by when; by whom; what outcomes we are seeking; how risk is managed and what is the contingency plan.



We will respect and promote the rights of children and families to ensure that we are culturally aware. Standard We will adopt anti-discriminatory and anti-racist 8 principles to promote equity, equality, diversity, and inclusion into our practice.
