Job Title: Welfare Benefit Advisor

## Overall purpose of the job

To provide a welfare benefits advice and claims support service for vulnerable people throughout Cambridgeshire and particularly service users with disabilities or long term illnesses.

Support the preventative aims of the Adult Early Help team by contributing towards a holistic support approach.

Act as point of expertise for internal teams and external partners on welfare benefits, supporting awareness raising, training and proactive take up of benefits.

## Main accountabilities

	Main accountabilities
1.	Provide advice, information and where necessary practical assistance in making timely claims for welfare benefits to ensure that income is maximised. Information and support will be provided over the telephone, in writing, by email or in person through home visits.
2.	Work with the Prevention and Early Intervention team to identify the support needs of individuals and family carers. Support with benefit claims and better off calculations to contribute to a holistic service that enables people to maintain their independence and reduce the need for social care input.
3.	Contact clients to check on progress and the award of welfare benefits, and where necessary advising the financial assessment service in a timely manner so that a reassessment of a person's contribution can be completed, and that the benefit take up can be recorded.
4.	Where appropriate advise and support people who we have assisted with benefit claims to challenge decisions through the Mandatory Reconsideration and appeals process.
5.	Manage own caseload and organise and plan work activities. Maintain case records by providing concise and accurate information about an individual's circumstances through the appropriate IT systems in line with professional requirements and departmental recording methods and standards of information governance and confidentiality.
6.	Work with internal and partner organisations to establish best practice and contribute to support networks in local communities to raise awareness and take up of Welfare Benefits.
7.	Demonstrate a commitment to continual professional development by accessing development opportunities, keeping up to date with changes to benefit and contribution policies and legislation by reading relevant publications and attending training sessions. Establish and build on knowledge of key county wide partners, support services, charities and community resources.
8.	To demonstrate awareness/understanding of equal opportunities and other people's behavioural, physical, social and welfare needs.
